SuperOnline™

SuperOnline is the safe, secure way to keep up to date with your super. The following features are available within SuperOnline to help manage your super:

- **My details.** View and update your contact details here.
- **My balance.** Wondering how much your super is worth? Obtain a current balance at any time.
- **My investment choice.** View and change your investment option online.
- **My contributions.** Your Contribution history shows any pre-tax, post-tax, employer contributions and any one-off payments you may have made to your super within a 12 month period.
- **Beneficiaries.** Nominate a beneficiary and keep this up to date using SuperOnline.
- **Statements.** View your Telstra Super Benefit Statements online.
- **Enquiry.** If you have a superannuation related question, you can send securely via SuperOnline.

Setting up your SuperOnline access

Go to www.telstrasuper.com.au and click on New User in the SuperOnline login box located on the right hand side of the homepage.

Enter your member number and PIN. If you do not have a PIN, call **1300 033 166** to request one today.

Once you have entered your details you can nominate your own password for future access. As with all secure online transactions, choose a password that's hard to guess but easy to remember, as you'll need it for future access!

Future access

Once you've set up your SuperOnline account you can access it at any time.

Next time you wish to use SuperOnline look out for the SuperOnline login box located on any page at www.telstrasuper.com.au. Simply enter your member number and password.

Calculators

The calculators can be found in the Tools & Forms section of the website. You can use our calculators to explore various scenarios and be better informed about your super.

Investment performance

Updated monthly, our investment performance page provides you with rolling 12-month, 3, 5, 7 and 10-year investment returns. You can also review our monthly market updates.

Unit prices

Your super's balance is calculated using daily unit prices. You can download and view a unit price performance graph or extract a history of unit prices.

Forms

If you're not comfortable doing things online, find a form and print it out to authorise changes to your address, preferred beneficiaries, investment choice, contributions and more. Use our Find a form tool in the Tools & Forms section to find the form you're looking for.

For details of your super arrangement visit the My super section on our website and select your product. If you can't remember which product you are in, use our interactive product selector to work out which arrangement you belong to.
